Subject: Updated Guidelines on Anti Money-Laundering standards and Countering the Financing of Terrorism, and Combating Proliferation Financing obligations for Dealers in Precious Metals and Precious Stones, under PMLA, 2002, UAPA, 1967, and WMDA, 2005, **dated 29.11.2023** - reg.

Kind attention is invited to the "Guidelines for Reporting Entities (Dealers in Precious Metals and Precious Stones) under the Prevention of Money Laundering Act, 2002" dated 25.01.2023 issued by DG Audit as Regulator on behalf of CBIC, which were updated vide guidelines dated 17.02.2023 and subsequently vide guidelines dated 04.05.2023.

2. In this regard, please find enclosed herewith the updated 'Anti-Money Laundering, Countering the Financing of Terrorism and Combating Proliferation Financing Guidelines for Dealers in Precious Metals and Precious Stones, 2023 under PMLA, 2002, UAPA, 1967, and WMDA, 2005, dated 29.11.2023'.

The guidelines have been updated consequent upon amendment in the Prevention of Money Laundering (Maintenance of Records) Rules, 2005, vide Notification G.S.R. 745(E) dated 17.10.2023, issued under F.No. P-12011/22/2023-ES Cell-DOR, by the Department of Revenue, Ministry of Finance, and **supersede the earlier guidelines dated 04.05.2023** issued by the Regulator.
